MINUTES OF COUNCIL MEETING

Held at Cardinham Parish Hall on Tuesday 16th February 2016

Present: Councillors J Best, G Tucker, P Tucker, T Irwin, Dr P Claridge, S Smart T Keat, G Rogers and County Councillor C Batters

There were 6 members of the public present.

Public Session

Mr Bonker mentioned that <u>with infrared heaters on we can hear the meeting and stay warm</u>. The Chair explained that the hall would shortly have the new equipment installed, including the hearing loop, which will be helpful where speakers are quietly spoken.

Milly mentioned that a vehicle had been blocking the postbox – this needs to be kept under observation to see if it is a regular occurrence. Also the area around the postbox needs clearing. Cllr Claridge explained that the St Meubred ride will unfortunately not be going ahead this year due to the A30works and resulting increase in traffic on the Fletchersbridge route. Parishioners will be informed.

County Councillors

The Chair welcomed Councillor Batters and invited him to give his report to the meeting. Cllr Batters began by mentioning that there was a huge backlog of work re highways due to the recent bad weather. Issues discussed/included in the report were as follows:

- Cemetery/flooding this issue was attended to very quickly, and the Parish Council thanks Cllr Batters for his prompt response, and also Cllr Tucker for attending on site.
- Dumped vehicle in Poundstock close
- Cabilla Manor Bridleway closed for several years now due to substantial flood damage that has got worse due to recent weather events. Engineers have looked at several options to resolve this challenging issue but matter is subject to Capital funding from Cornwall Council. An update will be received in the near future.
- Bridleway down Cardeast No 1 is already open but no 2 is not Mr Bonker kindly agreed to chase this up, explaining that modification orders generally need to be progressed by someone for any progress to be made.
- Large pothole reported Millpool to Cross Park Road Cormac informed, added to their jobs schedule.
- Fly tipping Reported to Cory and they attended. Would be helpful in future to have supporting photographs.
- Road at bottom of Treslea Hill condition reported, site visited by Cormac and added to future work schedule.
- Checking drains and gullies still checked on a rota but less regularly than in the past due to severe financial cutbacks but when issues arise they attend usually within 24 hours of receipt of email.
