MINUTES OF COUNCIL MEETING

held at Cardinham Parish Hall on Tuesday October 16th 2012.

The Chairman welcomed everyone to the meeting and before the meeting commenced she invited two of the public who were representatives of the residents of the area around Lanhydrock estate to express their concerns on planning application PA12/07801 which would be discussed later in the meeting.

12/ 131 Planning Applications

The Clerk explained that no correspondence had been officially received on this application but it should be discussed as it fringed onto the Parish boundary and would undoubtedly affect the local community.

PA12/07801 Land at Lanhydrock National Trust Estate – construction of new cafe, cycle hire buildings, toilets, creation of new car and coach parking areas, creation of new coach access on to Turfdown Road and new egress on to U6141 and works to the Carriage Drive: creation of cycle trails within the plantations north of Respryn Road and construction of cycle skills area/pump track south of Respryn Road and replacement children's play area.

After lengthy discussions the major comments that it was felt should be reflected to the Planning Officers were:

- Wonderful estate that was one of the most popular in the Westcountry.
- Peace and tranquility of the estate destroyed.
- Vast increase in traffic and visitor movement throughout the area
- Ecological damage caused by trails meandering through the woodlands.
- Disruption to the environment for walkers.
- Adequate nearby provisions for cyclists at Cardinham Woods & Camel Trail.

12/ 132 Planning Decisions

PA12 /08058 Mr & Mrs J Murray – replacement of timber garden store at Old Cardinham, Cardinham had been approved.

12/ 133 Footpaths

Cllr G Tucker had inspected all the footpaths and gave a detailed report on remedial work to be done.
