

CARDINHAM PARISH COUNCIL

MINUTES OF COUNCIL MEETING

Held at Cardinham Parish Hall on Tuesday 15th October 2019

Present: Councillors J Best, G Tucker, P Tucker, P Claridge, T Irwin, K Morris and 8 members of the public.

Public Session:

Issues raised were

- A parishioner raised the issue of highways and commented on the good work that Cormac have done recently in the village – potholes have been filled and edges of the roads have been done – and she thanked them for carrying out this work, saying how much it was appreciated.
- The overflowing and blocked drain outside the school has been reported by a resident of the parish.
- Concerns were raised about the possible impact on the surrounding area of a new planning application (change of use) particularly by the lighting and drainage.
- Churchyard – it has been noted that fencing is in place by the north gate – it was suggested this could be for health and safety reasons due to the ongoing works on the cottage there.

148/19 Minutes of the Previous Meeting 17th September 2019

- Discussion took place regarding the footpath/bridleway 32/44 and mention was made of the signage, which would have been removed during the war. The council came out of session in order to allow a member of the public to speak about this and the period around 1997. The council then went back into session.

155/19 Defibrillator

The Millpool defibrillator is in place. The posts are ready for the Little Downs defibrillator so they can be put in. The next item will be the training – Norman and Alan will arrange the instruction on procedures/training for Councillors and then the formal training for Millpool, Little Downs and Cardinham.

156/19 Footpaths

Queries received from a parishioner/visitor on 2 parish footpaths. Cllr Tucker will be able to help on these - clerk to pass Cllr Tucker's contact details to the parishioner/visitor to contact directly in order to ascertain the location of the paths in question.

- Positioning of the signs at the entrances to the village – Cllr T Irwin enquired as to whether the signs could be placed further out from the village to allow people to slow down before entering the built- up area. Clerk to contact highways.

Visitors often find it confusing/difficult to locate the Holy Well. It was resolved to purchase and erect a sign in order to assist in directing people to the correct area for the Holy Well and to prevent inadvertent trespass on neighbouring property, as requested by the property owner. Sign to be around 9" by 12". Clerk to action.
