MINUTES OF PARISH COUNCIL MEETING

106/22 County Councillors Report

Cllr Cruse provided a report on the following issues:

- Cllr Cruse congratulated everyone on how nice the flowers looked for the Jubilee weekend.
- It is likely that the Community Networks are to be replaced by Community Area Partnerships due to the increasing size of the area networks, possibly with more powers.
- The white paper on planning includes enforcement.
- Coastal / marine wildlife – policy to be considered by full council.
- Overgrown hedges – report if they are a safety/visibility issue. Please send list to Cllr Cruse.
- The date of the water quality presentation is 13th July.

107/22 Public Session

The following issues were raised:

- It was reported that a parishioner had received a letter regarding an enforcement issue and it was stated that unless damage is done then enforcement officers won't pursue the issue. In view of this it may be prudent to focus on more serious breaches.
- Two enforcement issues have been raised recently at Newbridge and Littledowns.
- It was noted that hedges are protected by the 1997 Hedgerow Protection, Countryside Act.

Thanks to Cllr G Tucker and Mr S Best for ensuring Health and safety protocols were in place, and special thanks to The Chair Cllr J Best and Vice Chair Cllr G Tucker for organising this event and ensuring everything was in place so it could go ahead. Everyone worked together to make this such an enjoyable and memorable evening for all.

113/22 Proposed Bus Route

115/22 Finance reports and payment of accounts

The receipts and payments report for June showed:

Further costs for the Jubilee were: Drinks £30.00, Consumables (ketchup, bin bags etc) £13.22, BBQ briquettes £18.00, Petrol for generator £5.00

Donations received at the event, after the above cost of £66.22 were taken into account, were £26.78. £10.50 banked as BACS and £16.28 cash still to be banked.

Cllr G Rogers proposed and Cllr R Dyer seconded to sign this month’s cheques. All in favour.

The Payments List, Budget to Actual comparison and a bank reconciliation had been prepared for the current period. These were forwarded to all the Councillors and added to the website.
